Russian and foreign investors are going to Ryazan

On 7th of October, potential investors will meet in Moscow with representatives of Ryazan enterprises and discuss cooperation opportunities. Meetings will take place within the framework of event «Investment days of Ryazan Region», organized by regional Ministry of Economic Development and Trade, together with Corporation of Development. On second day of the event – 8th of October – the business-trip to industrial sites and enterprises of Ryazan region is planned for participants, so they can learn about advantages of business development in the region.

«Investment days of Ryazan region» - is an event, which provides unique opportunity for an unbound dialog of regional authorities with investors, aimed at strategic development of priority investment projects of the region.

«We are living in an era of global economic changes, which main trend is gradual decentralization of investment space. With each passing year, investors attention is shifting from tightly competitive business environment of world mega polices to underestimated opportunities of the regions» - noted the Minster of Economic Development and Trade of Ryazan region, Vitaliy Larin in his greeting appeal to participants of Investment days.

During the first part of programme, within the plenary session, participants will discuss prospect spheres of investments to the regions and also the search of mechanisms for making a convenient regional business-environment and attractive investment climate in current economic situation. Also the business programme will be devoted to issues of legislative support of investments to innovative projects, development of small and medium enterprises in the regions. Certainly, the problem of economic sanctions will be noted: experts will share their opinion on this matter and answer the question, if the bans are a threat to Russian economy growth or they are new opportunities for business. Representatives of largest industrial enterprises will tell how to profitably use the industrial specific of the projects to raise funds.

Over 200 participants will visit the event platform, including representatives of federal authorities and Ryazan region Government, foreign embassies and trade offices in Russia, directors of regional industrial sites and largest Russian and foreign companies, investment funds and banks, trade chambers and profile associations, federal and specialized media, and also consultants for choosing industrial sites and supporting deals.

The event format is aimed at reaching certain results, and that's why the organizers pay special attention and create all conditions for efficient communication of participants – within the whole day, B2B-negotiations and business-meetings of investors' representatives, development institutes and projects starters will take place on the event platform.

More than 30 speakers are invited to hold speech on the event, including: Governor of Ryazan region Oleg Kovalev, Chairman of State Duma Committee for Economic Policy, Innovation Development and Entrepreneurship Igor Rudenskiy, Minister of Agriculture of Russia Nikolay Fedorov, Deputy of Minister of Finance of Russia, Alexei Moiseev, president of Trade and Industrial Chamber of Russia Sergey Katyrin. Business-community will be presented by heads of large enterprises: TechnoNikol, Yandex, Eurocement group and others.

Within the second day of the business programme, the business-tour on investment sites of Ryazan region will take place. This trip will allow event participants to study the sites for production allocation in the region (brownfields and greenfields) within a day, to evaluate advantages and specifics of industrial zones, personally.
