# INVITATION TO PRE-QUALIFY AND BID

## Civil Registry System - Information Technology Project II



Interested parties may obtain the Invitation Documents for CRS-ITP2 consisting of: (a) Invitation to Pre-qualify and Bid; (b) Information Memorandum; and (c) Instructions to Prospective Bidders, from the Pre-qualification, Bids and Awards Committee (PBAC) Secretariat Office, 11th floor, Cyberpod Centris One, EDSA cor. Quezon Ave., Quezon City with telephone number (+632) 374-8281 or telefax (+632) 374-8259, upon payment of a non-refundable fee of Php250,000.00. This fee may be paid in cash or in Manager's Check issued by a bank in the Philippines payable to the Philippine Statistics Authority (PSA). The Invitation Documents will be available starting 18 September 2015 anytime from 9:00a.m. to 4:00p.m. The PSA may release updates, clarifications, or additions to any or all of the said documents.

The Pre-qualification, Bids and Awards Committee (PBAC) invites prospective bidders to submit applications to pre-qualify in bidding to finance, design, develop, operate, and maintain the Civil Registry System-Information Technology Project II (CRS-ITP2). The CRS-ITP2 is a successor project to CRS-ITP implemented since 2000. It will involve the computerization of the civil registry operations of the PSA and is designed to collect, access, store, maintain and manage civil registry documents and the specimen signatures of all city/municipal civil registrars using imaging technology. The CRS-ITP2 will also include production of vital statistics and makes the civil registry services available nationwide through the CRS outlets and other authorized partners.

The Project will be awarded through a competitive public bidding, as a Public-Private Partnership (PPP) project, in accordance with Republic Act No. 6975 as amended by Republic Act No. 7718 (The Philippine Amended BOT Law), its Implementing Rules and Regulations and other applicable laws, through the BTO contractual arrangement.

The Bidding will follow a two-stage process:

- (1) Prospective bidders shall first be pre-qualified based on legal, technical, and financial capability requirements; and
- (2) Pre-qualified bidders will be invited to submit bids.

Only entities that purchased the Invitation Documents shall be allowed to participate in the pre-qualification process.

Interested parties must submit their applications for pre-qualification, together with the duly accomplished pre-qualification documents in the required number of copies and format, to the PBAC Chairperson, through the PBAC Secretariat, on or before the Qualification Document Submission Date as provided in the ITPB or bid bulletins. Late submissions shall not be accepted.

The PSA reserves the right to accept or reject any bid, annul the bidding process, or reject all bids at any time prior to contract award, without incurring any liability to the affected bidder or bidders.
