The Government of the United Republic of Tanzania has received financing from the World Bank toward the cost of the Tanzania Intermodal and Rail Development Project (TIRP), and intends to apply part of the proceeds toward payments under the contract for Supply of Forty Four New Freight Flat Wagons.
